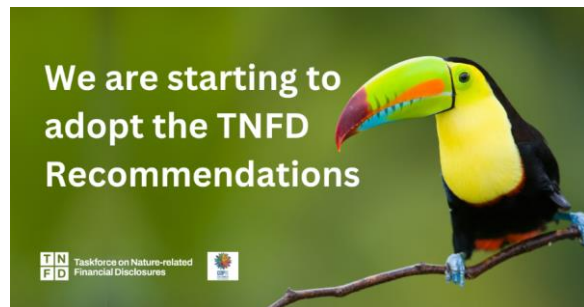




EIZO Adopts TNFD Disclosure Recommendations to Enhance Commitment to Nature and Biodiversity

Hakusan, Japan, October 29, 2024 – EIZO Corporation (TSE: 6737) today announced its adoption of the disclosure recommendations published by the Taskforce on Nature-related Financial Disclosures (TNFD)ⁱ. EIZO announced that it has registered as a TNFD Adopterⁱⁱ at the 16th meeting of the Conference of the Parties (COP16) to the United Nations Convention on Biological Diversity held in Cali, Colombia from October 21 to November 1, 2024.

TNFD is a global initiative aimed at creating a framework for organizations to assess and disclose the impact of their economic activities on nature and biodiversity. The recommended disclosures are structured around four pillars: governance, strategy, risk and impact management, metrics and targets. EIZO will analyze its activities using the LEAP approachⁱⁱⁱ and disclose its detailed initiatives in accordance with the TNFD recommendations within FY2024.
